 - a. Inclusion of FAST ACT signed into law on 12/4/15-provides long-term funding for surface transportation planning and investment.

 - a. <u>Oakland Road project:</u> is scheduled to be let to contract in the December 2016 letting with the TDOT, SR-13 project being amended above.

b. CTS update:

<u>Comprehensive Operations Analysis (COA)</u> will be completed by the end of August by AECOM consultants;

<u>Transfer Center Relocation Study</u> is being handled by Parson Brinkerhoff (PB) consultants and will be completed in November.

- c. <u>I-24@ Exit 8/SR-237/Rossview Road</u>: TDOT has completed the widening of SR237 to 5 lanes from I-24 to International Boulevard and the I-24 interchange modification project (There is still dirt work remaining.
- d. The Park & Ride facility site at Exit 11/SR-76: is under construction and is expected to be completed this fall. The Park & Ride facility site at Exit 8 will remain open until the new site is finished.
